As a responsible manufacturer with many years' experience supplying the hotel market, we are constantly mindful of the need to comply with current legislation in respect of Fire Safety standards.

There is also a duty of care on the part of the hotel operator and their specifiers to ensure that relevant products and materials are properly tested and certificated in accordance with the current Fire Retardancy (FR) standards.

Where customers specify their own fabric for the upholstery of divans, we are then required to fire test as a composite. FR certification is needed **BEFORE** we can begin to process the order. The order will therefore commence from the date of receipt of the certification of the divan in question.

All divan fabric must achieve the standard of BS 7177 (Medium Hazard) Ignition Source 5 (Crib 5). If the FR certificate states compliance to BS 7177 (Medium Hazard) Crib 5 then the order can be processed.

The certificate must state the following: -

- Full description of the divan composite
- Compliance with BS 7177 (Medium Hazard) Crib 5 - please note BS5852 (Domestic Usage) will not suffice
- Full description of the test BS 7177 (Medium Hazard) Crib 5
- Name of the (accredited) test house
- Date of test (the certification date should not be more than 12 months old at the time of specification / order, or it becomes invalid)

All sofa bed and headboard fabric must achieve the standard of BS 7176 (Medium Hazard) Ignition Source 5 (Crib 5). If the FR certificate states compliance to BS 7176 (Medium Hazard) Crib 5, then the order can be processed.

The certificate must state the following: -

- Full description of the fabric
- Compliance with BS 7176 (Medium Hazard) Crib 5 - please note BS 5852 (Domestic Usage) will not suffice
- Full description of the test BS 7176 (Medium Hazard) Crib 5 - method used within this standard is as follows: - BS EN1021-1 and 2 and BS 5852 (Domestic Usage)
- Name of the (accredited) test house
- Date of test (the certification date should not be more than 12 months old at the time of specification / order, or it becomes invalid)
